Minutes: Director Jacobsen provided the board with an overview of the Maintenance Ordinance (75 ILCS 5/3-4), which allows the library to levy an additional tax of .02% of the value of all the taxable property in the district using a backdoor referendum process. He explained that although this ordinance allows for the additional tax, it is not used unless the library reaches the tax cap. He also explained that it was recommended to him by a library attorney to pass this ordinance each year to establish a pattern just in the case it is ever desired by a Board. The board agreed to add the Maintenance Ordinance to the July board meeting agenda.

> Director Jacobsen presented the Tentative Budget & Appropriation Ordinance to the board for review and discussion. He explained that the B&A Ordinance provides legal authority for the library district to allocate funds to specific spending activities. It also establishes the library's legal spending limit for the fiscal year. The appropriation is the upper limit that the library is permitted to spend in a budgetary line before returning to the board for an adjustment. He informed the board that slight adjustments were made to the legal, consultants, and utilities budgetary lines, which were highlighted in the draft provided.

> The Board will adopt the B&A Ordinance at the July 13, 2020 board meeting in tentative form. The public hearing for the B&A is scheduled for Monday, August 24, 2020 at 6:30 PM.
