Dental insurance coverage discussion – currently the library does not offer any assistance with dental insurance coverage. Director Jacobsen provided the board with the findings of a survey he conducted on how much other libraries subsidize for dental insurance. As a result, we would like the board to consider offering 100% dental insurance coverage for single care plans and 56% of dental coverage for dependent care plans, which aligns with the current coverage being offered for medical insurance. After much discussion, the board requested that Director Jacobsen obtain information from neighboring libraries (Antioch, Fox Lake, Round Lake and Warren) before they make a decision on possibly offering this additional benefit. Director Jacobsen will share the

information he receives at the next board meeting.
