FY 24/25 Tax Levy — Trustee Smith asked if the board had any additional questions regarding the tax levy. Approval of the Annual Tax Levy Ordinance will be on the October board meeting agenda.

FY 24/25 Bond Abatement Ordinance – Approval of the Bond Abatement Ordinance will be on the October board meeting agenda. The abatement saves library tax payers about \$335,000.

Library Investment posture and Special Reserve Fund plan – the board discussed the bond debt that can potentially be paid off in December 2026. Since current interest rates are above the library's debt interest rate, the board may consider to delay paying the bond off early as long as the rates continue to earn more than the library would pay in debt interest rates. The consensus of the board was to not pay off the debt as long as the rates continue to be above the library's debt interest rate. Director Jacobsen will discuss with the library's attorney to draft a motion for the board to approve for this approach.
