Annual Budget & Appropriation (B&A) Ordinance & Estimate of Revenues – Director Jacobsen presented the tentative B&A ordinance and the estimate of Revenues for fiscal year 2024/2025. He explained that the process is designed to set the appropriated amount (upper limit) the library is able to spend per a budgetary category without returning to the board for explicit permission. Typically, the appropriated amount is 20% more than is budgeted in the various budgetary lines, but some may be higher to provide a little more space for unanticipated expenses. The tentative B&A ordinance will be on the agenda for consideration to adopt at the July board meeting. The public hearing date is scheduled for August 26.

.02% Maintenance Levy Ordinance – Treasurer Smith and Director Jacobsen explained that the ordinance allows the library district to levy an additional tax of .02% of the value of all the taxable property in the district. They also explained that the levy needs to be passed at least once every 3 years to continue to have the option of someday using this additional .02%. Although the board passed the .02% Maintenance Levy Ordinance in FY24, it is recommended for the board to pass it annually in order to simplify accounting practices.
