Minutes: Ordinance 26-101 – Amendment to the Special Reserve Fund Plan - Director Jacobsen explained that under 75 ILCS 16/40-50, the ordinance allows a library district to set aside funds specifically for capital purposes. These purposes may include building repairs, renovations, construction, land acquisition, architectural or engineering planning, major equipment purchases, payment of construction debt, or other significant improvements. The law requires the board to identify the specific purposes for which the fund may be used, and the money can only be spent on those approved capital needs. As such, the ordinance serves as a long-range planning tool to ensure the library is financially prepared for future projects and major expenditures.

LVDL's Special Reserve Fund Plan Ordinance has not been updated since 2021. At this time, it is appropriate to revise the ordinance to explicitly include improvements to the library grounds, consistent with the statute but not clearly stated previously. An additional provision referencing the possibility of a future branch location was also added. While a new branch is not currently being pursued, this inclusion ensures that any future board would be able to use the Special Reserve Fund for that purpose if desired.

The board will consider adopting the amended ordinance at the January board meeting.
